To All Parties and Interested Persons:

On January 6, 2023, the State Water Resources Control Board (State Water Board) provided an extension of time to file responses to the above-referenced petition and file the administrative record from January 20, 2023, to February 24, 2023. The State Water Board subsequently received letters dated January 6, 2023, and February 13, 2023, from counsel for RTG Investments, LLC and the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board), respectively, requesting further extensions of time to respond to the above-referenced petition and file the administrative record. A second extension of time is hereby granted.

The new deadline for any person who would like to file a response to the petition is now 5:00 p.m. on March 17, 2023. All responses should be emailed to me at [philip.wyels@waterboards.ca.gov](mailto:philip.wyels@waterboards.ca.gov). Copies of all responses should also be sent to the email addresses of all parties and interested persons listed below. The Los Angeles Water Board shall also file the administrative record by 5:00 p.m. on March 17, 2023, and provide access to the administrative record to all parties and interested persons. Please note that there will be no further extensions of time.

In its January 6, 2023 letter, counsel for RTG Investments, LLC also raises several issues related to the petition and asks that the State Water Board dismiss the petition. The State Water Board will consider these issues as it reviews the petition, the responses, and the administrative record. Therefore, the request to dismiss the petition is hereby denied without prejudice.
